(b) Assessing implications of measures taken for the economy and sectors heavily impacted by the crisis,


(a) Assisting policy makers to design alternative policy solutions through evidence-based analysis corresponding to different scenarios

#### What is a CGE model?


Macroeconomic models that use empirical data to provide evidence-based economy wide analysis and numerical data on the impact resulting from changes in policy, technology, or external shocks

A standard and vital tool for policy making used by many Governments and Development Partners





## MODELLING TECHNICS VARIES VIS-À-VIS REFORMS THE UNESCWA TOOL BOX







